#### **CHAPTER I**

### 1.1 Background of Study

Characters in literary work have two meanings. They are character as people or doer in the story and people's trait in the story. Characters as people can be defined by their physical appearances such as their body, skin color, hair, weight, high. On the other hand, character as people's trait means people's quality, peoples' mental that can be seen from their behavior to respond everything in life.

There are many kinds of charactersor traitsowned by people. ### 1.4 Significance of Study

By analyzing Sammy's character development, the writer hopes that this thesis will help the readers to understand about character development. The thesis writer also hopes

## 1.5 Scope and Limitation of the Study

There are many aspects that can be analyzed and found in this novel. The writer, however, limits the study on the main character in the novel, Sammy, especially his character development.

#### 1.6 Research Method

In this thesis, descriptive qualitative research is used. Krathwohl states in *Methods of Education and Social Science Research: An Integrated Approach* that Qualitative research is a research that explains a phenomenon in word instead of number or measure (Krathwohl, 1993: 740). The source of the data used in this research is William Sleator's *Fingers* The data are in form of quotations from the novel. Besides, the theory of character is also presented because the research uses intrinsic approach. Intrinsic approach is approach used to analyze a literary work based on the literary element such as plot, character, theme, point of view, setting etc (Abrams, 1979: 26). However, this study is focused on the character. Thus, the data collection analysis and theory should be related to each other (Corbin and Strauss, 1990: 23). All problems related to the topic in William Sleator's *Fingers* will be analyzed. All quotations that can be found will describe, illustrate, support, and strengthen the topic (Bogdan, 1982: 28)

The thesis writer will discuss and reveal the character's development in William Sleator's *Fingers*. The main character in thisnovel is Sammy. Sammy's

character will be analyzed to find what kind of character's development he gets, how the process of character's development is, and how the result of character's development is in order to prove that Sammy has character development.

# 1.7 Organization of the Study

This thesis is divided into four chapters. Chapter one is the introduction of the thesis and it contains background of the study, problem statement, objective of the study, significance of the study, limitation of study, research method, and organization of the study. Chapter two is review of related literature. It contains the definition of elements of literature such as plot, character, theme, setting, point of view. In chapter three the thesis writer explains about Sammy's character development and it is divided into three subchapters. The three subchapters are: Sammy's character before Humphrey's runaway, the process of Sammy's character development, and Sammy's character after Humphrey's runaway. Chapter four is conclusion of the study. Conclusion contains the summary of chapter three.
