### CHAPTER I

'Social life theory' – clearly referring to work within the discipline of sociology, and our main focus here can be used in the former sense to describe an explanation which takes the form of an assertion that can be tested. However, it can also denote a framework for viewing the social world that is too general, too broad and too all-encompassing to be confirmed or refuted by empirical research; indeed, the kind of empirical research we choose to do will be profoundly shaped and influenced by the framework in the first place.
