

### **ABSTRACT**

In patriarchal society, men are in a superior position than women. In this society men should be in charge and women should follow along, this causes women to be placed in a subordinate or inferior position. Patriarchy is important to discuss because Patriarchy is a socially-constructed system where males have primary power.
