CHAPTER I

INTRODUCTION

1.1 Background of the Study

Novel have three basic elements that consists of plot, character and settings. Plot is sequence of events inside a story. A plot summary may include what character say or think, as well as what they do, but it leaves out description and analysis and concentrates primarily on major events. From the sequence of event author could create some kinds of conflict. (Thomas R.Arp & Greg Jonson, 2009:45)

It can be refered that conflict is situation that a person struggle with opposing force such as social, nature or himself to accomplish their desire.
